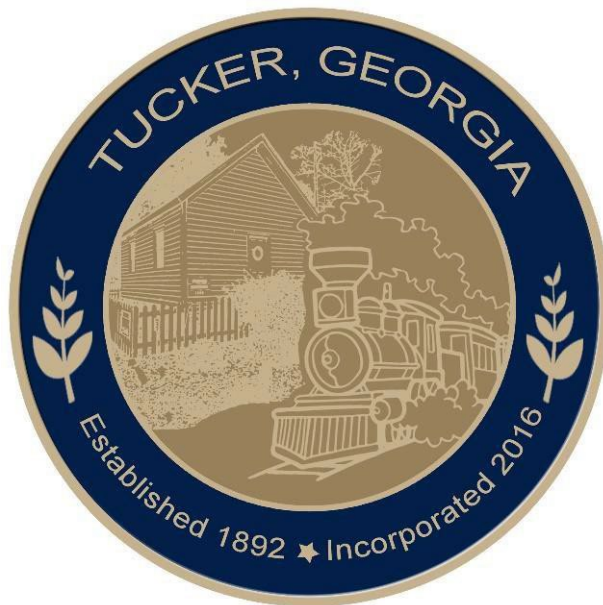

ADDENDA: Responses to the questions received will be by addenda and will be posted on the City website www.tuckerga.gov/bids and the DOAS/Georgia Procurement Registry Website. The signed acknowledgement issued with each addendum must be submitted with the proposal. It is the vendors responsibility to verify if any addenda were created.

SUBMITTAL REQUIREMENTS: Vendor shall submit ITB Response electronically to procurement@tuckerga.gov so it is received no later than December 4, 2025, at 1:00pm EST with the subject line "Submittal: ITB #2025-018". The email must contain the vendor's contact information. Bid Submittal should be one PDF file and named <Company Name>.ITB 2025-018.Bid Submittal.pdf. Email will be opened to confirm receipt of the submittal, but the attached PDF file will remain unopened until the public bid opening.

BID OPENING: All bids received prior to the deadline will be opened publicly at 1:00pm EST at Tucker City Hall located at 1975 Lakeside Parkway, Suite 350, Tucker GA.

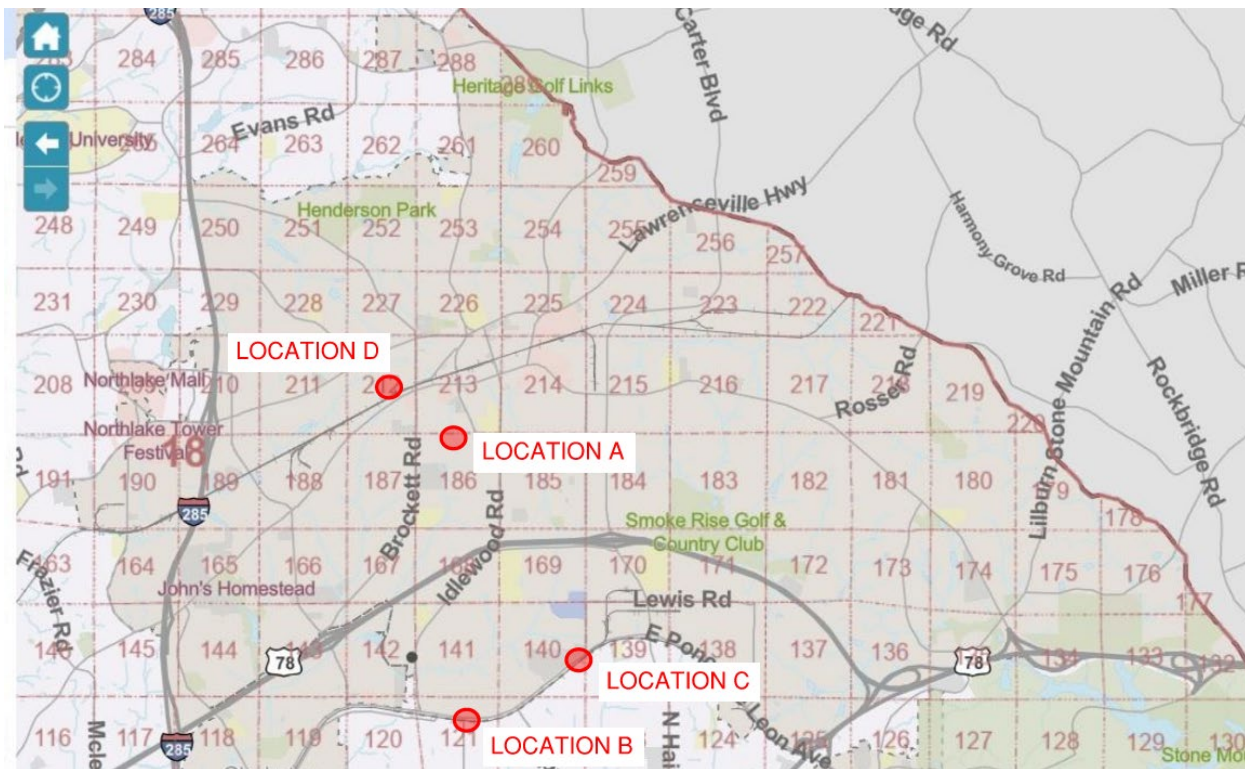
PURPOSE, INTENT AND PROJECT DESCRIPTION

The City of Tucker (City), requests that interested parties submit formal electronic bids for the replacement of failed culverts and associated catch basin structures and headwalls at four (4) locations.

The complete scope, specifications, and other relevant information for ITB 2025-018 is available for download on the City of Tucker website: www.tuckerga.gov/bids or request via email to procurement@tuckerga.gov.

SCOPE OF WORK

The work required under this contract includes furnishing materials, qualified labor, equipment, traffic control, erosion control, and site restoration at each location as described in the accompanying construction plans.



LOCATION A: 4127 PINE VALLEY ROAD

Project Background

The existing storm drainage system and culvert under Pine Valley Road has experienced emerging failure of the existing 30" metal pipe. A new culvert and associated structures need to be installed to properly drain the area upstream of Pine Valley Road for the long term structural soundness of the road.

LOCATION B: CULVERT UNDER EAST PONCE DE LEON AVENUE AT 1566 SAGEWOOD CIRCLE FRONTAGE

Project Background

The existing storm drainage system and culvert under East Ponce de Leon Avenue has experienced failure due to a collapsed conduit under East Ponce de Leon Avenue. A new culvert and associated structures need to be installed to properly drain the area upstream of East Ponce de Leon Avenue for the long term structural soundness of the road.

LOCATION C: 5170 EAST PONCE DE LEON AVENUE

Project Background

The existing storm drainage system and culvert under East Ponce de Leon Avenue has experienced failure due to a complete sedimentation of the system. A new culvert and an associated inlet structure need to be installed to properly drain the area upstream of East Ponce de Leon Avenue for the long term structural soundness of the road.

Location Notes

1. Abandon the existing system in place and remove existing catch basin structure top to a point of existing shoulder grade.
2. Install a 30" RCP culvert under East Ponce de Leon Avenue and the multi-use trail. Approximately 120 linear feet of 30" diameter RCP pipe - see accompanying exhibit.
3. Install headwalls at each end.
4. Install a pedestal top inlet junction box in the shoulder on the north side of East Ponce de Leon Avenue to capture ditch and roadway surface drainage from an uncurbed section.
5. Outlet and inlet protection per GSWCC Erosion Control Manual Structural Measure St1.
6. Pavement repair of road and multi-use trail to match existing pavement cross section.
7. Clean work area.

Special Notes

1. The city has obtained an easement and right of entry from the cemetery to drain outletting flow onto the cemetery property.

LOCATION D: 2241 MOON STREET

Project Background

The existing storm drainage system and culvert under Moon Street has experienced failure due to a complete sedimentation of the system. A new culvert and an associated inlet structure need to be installed to properly drain Moon Street and avoid excessive ponding.

Location Notes

1. Sawcut roadway and remove the existing conduits, catch basin structures, and headwall, approximately 80 linear feet.
2. Install an 18" diameter RCP culvert under Moon Street and an 18" diameter HDPE pipe outfall to the north. Approximately 35 linear feet of 18" diameter RCP pipe and 45 linear feet of 18" diameter HDPE pipe - see accompanying exhibit. Match existing elevations.
3. Install headwall at downstream end.
4. Install catch basins on each side of Moon Street.
5. Outlet and inlet protection per GSWCC Erosion Control Manual Structural Measure St1.

6. Pavement repair of road to match existing pavement cross section.
7. Uninstall prior to and reinstall subsequent to pipe installation a section of chain link fence with barbed wire, about 50 linear feet.
8. Clean work area.

GENERAL LOCATION NOTES

The prospective bidder is advised to visit the sites.

Please reference the accompanying exhibits (for locations C and D) and construction plans (for locations A and B) for more detailed information on the scope of work and locations of structures and conduits. 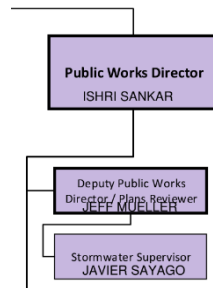

GENERAL CONDITIONS

The contractor shall execute the work according to and meet the requirements of the following:

- Maintain access to residential properties as necessary by detours or covering of the work area when not mobilized.
- Mobilization will be defined under Section 151 of the 2021 Standard Specifications of the Georgia Department of Transportation. One mobilization shall include the cost of mobilization for all teams and subcontractors used by and at the discretion of the Contractor.
- Furnish, install, maintain, and remove all necessary traffic signs, barricades, lights, signals, cones and other traffic control devices, and all flagging and other means of traffic protection and guidance as required by Special Provision 150 of the Georgia Department of Transportation. Such work shall be considered incidental to the overall contract, and no additional compensation will be made.
- Be responsible for calling in GEORGIA 811 and identifying utility locations. The City shall be notified of any potential utility conflicts.
- Conduct the work within the city right of way. The city will obtain all easements and rights of entries which may be necessary to execute the repair.
- Specifications for repair activities in accordance with Georgia Department of Transportation Standards.
- City of Tucker ordinances and regulations.
- OSHA standards and guidelines.
- Any other applicable codes, laws and regulations including but not limited to Section 45- 10-20 through 45-10-28 of the Official Code of Georgia Annotated, Title VI of the Civil Rights Act, Drug-Free Workplace Act, and all applicable requirements of the Americans with Disabilities Act of 1990.
- All disturbed areas shall be restored to site conditions prior to disturbance, or better.
- Reinforced Concrete Pipe (RCP) is to be Type 3. This line item includes all labor, material and equipment costs associated with excavation, placement, bedding, backfill and compaction.
- “Grading Complete” are those activities, including but not limited to excavation, demolition, backfill and grading not identified in the unit price quantities schedule to ensure that the completed grading work conforms to the horizontal and vertical alignment and typical cross-sections shown on the plans or directed by the engineer of record.

- Refer to organization chart below for city assigned staff for this project. The city reserves the right to substitute staff at any time during the contract period.



The contractor will be responsible for providing all labor, materials, and equipment necessary to perform the work. This is a unit price bid. Payment will be made based on actual work completed.

The contractor is responsible for inspecting the job site prior to submitting a bid and encouraged to do so. No change orders will be issued for differing site conditions.

5% retainage will be withheld from the total amount due the contractor until Final Acceptance of work is issued by the City. City staff will inspect the work as it progresses.

PROSECUTION AND PROGRESS

The Contractor will mobilize with sufficient forces such that all construction identified as part of this contract shall be substantially completed by 120 calendar days. The contractor will be considered substantially complete when all work required by this contract has been completed.

The normal workday for this project shall be 8:00AM to 7:00PM and the normal workweek shall be Monday through Friday. The City will consider extended workdays or workweeks upon written request by the Contractor on a case-by-case basis. No work will be allowed on national holidays (i.e. Memorial Day, July 4th, Labor Day, etc.).

The work will require the bidder to provide all labor, administrative forces, equipment, materials and other incidental items to complete all required work. The City shall perform a Final Inspection upon substantial completion of the work. The contractor will be allowed to participate in the Final Inspection. All repairs shall be completed by the contractor at the contractor's expense prior to issuance of Final Acceptance.

The contractor shall be assessed liquidated damages in the amount of \$500.00 per calendar day for any contract work that is not completed by 120 calendar days. Liquidated damages shall be deducted from the 5% retainage held by the City. The contractor will also be assessed liquidated damages in the amount of \$200.00 per calendar day for not completing any required Punch List work within 45 calendar days.

The contractor shall provide all material, labor, and equipment necessary to perform the work without delay until final completion.

PERMITS AND LICENSES

The contractor shall procure all permits and licenses, pay all charges, taxes and fees, and give all notices necessary and incidental to the due and lawful prosecution of the work.

BONDING AND INSURANCE REQUIREMENTS

No bid may be withdrawn for a period of ninety (90) days after the bid deadline/opening.

All bids must be accompanied by a Bid Bond of a reputable bonding company authorized to do business in the State of Georgia, in an amount equal to at least five percent (5%) of the total amount of the bid.

Upon Notice of Award, the successful contractor shall submit a Performance Bond payable to the City of Tucker in the amount of 100% of the total contract price. The successful contractor shall also submit a Payment Bond in the amount of 100% pursuant to O.C.G.A. § 36- 91-70 and 90.

Upon Notice of Award, the successful contractor shall procure and maintain the following insurance policies:

1. Commercial General Liability coverage at their sole cost and expense with limits of not less than \$3,000,000 in combined single limits for bodily injury and/or property damage per occurrence, and such policies shall name the City of Tucker as an additional named insured.
2. Statutory Workers Compensation and Employers Liability Insurance with limits of not less than \$1,000,000, which insurance must contain a waiver of subrogation against the City of Tucker and its affiliates.
3. Commercial automobile liability insurance with limits of not less than \$1,000,000 combined single limit for bodily injury and/or property damage per occurrence, and such policies shall name the City of Tucker as an additional named insured.

EXISTING CONDITIONS / DEVIATION OF QUANTITIES

All information given in this ITB concerning quantities, scope of work, existing conditions, etc. is for information purposes only. It is the Contractor's responsibility to inspect the project site to verify existing conditions and quantities prior to submitting their bid. This is a Unit Price bid and no payment will be made for additional work without prior written approval from the City. At no time will Contractor proceed with work outside the prescribed scope of services for which additional payment will be requested without the written authorization of the City.

The City reserves the right to add, modify, or delete quantities. The City may also elect to add or eliminate certain work locations at its discretion. The Contractor will not be entitled to any adjustment of unit prices or any other form of additional compensation because of adjustments made to quantities and/or work locations. Contractor will be paid for actual in-place quantities completed and accepted for pay items listed in the Bid Schedule. All other work required by this ITB, plans, specs, standards, etc. but not specifically listed in the Bid Schedule shall be considered "incidental work" and included in the bid prices for items on the Bid Schedule.

TRAFFIC CONTROL

The contractor shall, at all times, conduct their work so as to assure the least possible obstruction of traffic. The safety and convenience of the general public and the residents along the roadway and the protection of persons and property shall be provided for by the contractor as specified in the State of Georgia, Department of Transportation Standard Specifications Sections 104.05, 107.09 and 150.

Traffic whose origin and destination is within the limits of the project shall be provided ingress and egress at all times unless otherwise specified by the City. The ingress and egress includes entrances and exits via driveways at various properties, and access to the intersecting roads and streets. The contractor shall maintain sufficient personnel and equipment (including flaggers and traffic control signing) on the project at all times, particularly during inclement weather, to ensure that ingress and egress are safely provided when and where needed.

Two-way traffic shall be maintained at all times, unless otherwise specified or approved by the City. In the event of an emergency situation, the Contractor shall provide access to emergency vehicles and/or emergency personnel through or around the construction area. Any pavement damaged by such an occurrence will be repaired by the Contractor at no additional cost to the City.

The contractor shall furnish, install and maintain all necessary traffic signs, barricades, lights, signals, cones and other traffic control devices, and all flagging and other means of traffic protection and guidance as required by Special Provision 150 of the Georgia Department of Transportation. Such work shall be considered incidental to the overall contract, and no additional compensation will be made.

CLEANUP

All restoration and clean-up work shall be performed daily. Operations shall be suspended if the contractor fails to accomplish restoration and clean-up within an acceptable period of time. Asphalt and other debris shall be removed from gutters, sidewalks, yards, driveways, etc. Failure to perform clean-up activities may result in suspension of the work. Milling operation shall be followed immediately by clean-up at which the contractor is to provide power brooms, vacuum sweepers, power blowers, or other means to remove loose debris or dust. Do not allow dust control to restrict visibility of passing traffic or to disrupt adjacent property owners. All pavement areas shall be clean and dry prior to placing tack coat, asphaltic concrete or other materials.

SAFETY

Beginning with mobilization and ending with acceptance of work, the contractor shall be responsible for providing a clean and safe work environment at the project site. The contractor shall comply with all OSHA regulations as they pertain to this project.

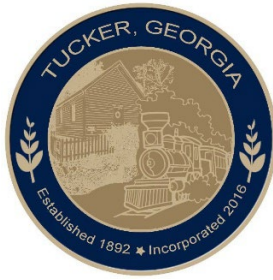
